Guidelines for Applicants to the 2025 Master's Program Graduate School of Frontier Sciences The University of Tokyo

• Examinations may be switched to an online format due to the impact of COVID-19. If changes are made to these guidelines, we will publish the changes on the Graduate School website so please check it regularly.

For non-Japanese applicants

Foreign nationals who are newly entering Japan to enroll in a graduate school must, in principle, have landed in Japan with the status of residence, "Ryugaku (student)", by the date of enrollment. Please refer to the subsequent section (11. Notes, (7)) for more information.

In order to have your status of residence determined upon landing, you will need a Certificate of Eligibility (CoE). Host institutions will apply for CoEs on behalf of prospective students and will become ready to start the application procedures only after successful candidates are notified of admission. CoEs are usually issued three months after host institutions file applications. Therefore, non-Japanese applicants planning to newly enter Japan are fully expected to choose "April Admission" in the entrance examination Schedule A, and "October Admission" in the entrance examination Schedule B (Please refer to "1. Admission Period".).

Purpose

Established in 1998 through a comprehensive cooperation of all departments and divisions of The University of Tokyo, the Graduate School of Frontier Sciences (GSFS) embodies a new transdisciplinary field, created as an independent research entity, providing master's and doctoral degree courses only. GSFS aims to take up the challenge of finding solutions to current key issues restricted by the very framework that separates the fields of science and technology, by adopting entirely new standards, which will allow for integration among conventional academic fields. In the past, science has overemphasized the quest for scientific truth in strictly defined fields of study, frequently overlooking interrelationships between the different fields resulting in a narrow overall perspective. GSFS considers it essential to further intellectual pursuits addressing today's reality by creating a new disciplinary field that embodies an overarching view of several disciplines, allowing in-depth recognition of their interrelationships. In order to confront this challenge resolutely from a new and unique perspective, GSFS defines "fusion of academic fields" as its basic philosophy and offers educational and research opportunities in the unexplored areas that would otherwise be restricted by existing academic fields. This program is for "fully globally minded" students desiring to explore emerging concepts requiring a cross-dimensional viewpoint, with highly developed problem-solving capabilities.

Admission Policy

1. GSFS students

For the master's program, GSFS seeks students who have acquired sufficient basic academic skills to learn their desired area of study and related fields and language and communication skills and will produce transdisciplinary research results in the future.

2. Basic policy for admissions selection

Based on the above (1. GSFS students), the following aspects will be comprehensively evaluated and selected by individual academic ability tests including written and oral examinations.

- · Basic knowledge of their desired area of study and related fields
- Capability to think and explain logically
- · Capability to communicate in English
- · Capability to find and solve research problems on one's own
- · Desire to actively learn a broad range of academic disciplines

Introduction

Guidelines Objective

These guidelines outline the basic items for admitting students to a master's program in GSFS. In addition to the basic items described, more details on the requirements specific to each department*, as well as entrance examinations and other important matters are specified in the entrance examination guide of each department. Also, be sure to confirm specific details using the following website (GSFS exam website https://www.k.u-tokyo.ac.jp/en/exam/info/).

*GSFS has 11 departments and one program: Graduate Program in Sustainability Science which conducts its own independent entrance examination. Whenever *department* (s) or *each department* is referred to in these guidelines, the Graduate Program in Sustainability Science is included.

1. Admission Period

April 2025

- These guidelines are for students applying for April 2025 admission. However, depending on departments, applying for October 2024 admission may be possible under Schedule A, and applying for October 2025 admission may be possible under Schedule B. Please refer to the entrance examination guide of each department or relevant website for details.
- Please note that successful applicants who plan to apply for a CoE through GSFS will only be admitted in April from taking the entrance examination Schedule A, and only in October from taking the entrance examination Schedule B.
- Those applying for October 2024 admission under Schedule A should read "March 31, 2025" as "September 30, 2024" in the subsequent section: 2. Applicant Eligibility, (1) and (2).
- Those applying for October 2025 admission under Schedule B should read "March 31, 2025" as "September 30, 2025" in the subsequent section: 2. Applicant Eligibility, (1) and (2).

2. Applicant Eligibility

Those who fall under any of the following categories are eligible to apply.

(1) Regular Admission

- ① Those who have graduated, or are expected to graduate, from a Japanese university¹ by March 31, 2025. ^{1,5}
- ② Those who have completed, or are expected to complete, 16 years of school education abroad by March 31, 2025.^{2,5}
- ③ Those who have been conferred, or expected to be conferred by March 31, 2025, a degree equivalent to a bachelor's degree from a foreign university or other foreign institution (limited to those whose comprehensive status of education and research activities have been assessed by the government of the said foreign country or a related organization), having completed a program with a completion period of 3 years or more.^{2,5}
- ④ Those designated by the Minister of Education, Culture, Sports, Science and Technology or those who have graduated or are expected to graduate by March 31, 2025, from an educational institution designated by the Minister.^{3,5}
- ⑤ Those who have been conferred, or are expected to be conferred a bachelor's degree on or before March 31, 2025, by the National Institution for Academic Degrees and Quality Enhancement of Higher Education (NIAD).⁵
- ⑥ Those who will be twenty-two (22) years of age or older by March 31, 2025, and have been recognized as having academic abilities that are at least equivalent to those who have graduated from a Japanese university based on individual screening of entrance qualifications by GSFS. However, those who are registered as an undergraduate student shall not qualify for the individual screening of entrance qualifications.^{1,4,5}

(2) Special Selection for Applicants with Overseas Education

Those who fall under any one of ① Basic Qualifications and also fall under any one of ② Requirements are eligible to apply.

- (1) Basic Qualifications
- I. Those who fall under any of the above eligibility ① through ⑤ of this section: 2 (1) Regular Admission.
- II. Those who fulfill all eligibility (a) through (c). 4
 - (a) Graduated from an educational institution equivalent to a four (4)-year university, and have been recognized, through individual screening of entrance qualifications by GSFS, as having abilities at least equivalent to those who have graduated from a Japanese university.¹
 - (b) Those who have been recognized by GSFS as having sufficient education while living in a foreign country to qualify for the Special Selection for Applicants with Overseas Education.
 - (c) Those who will be twenty-two (22) years of age or older by March 31, 2025. 5

2 Requirements

- I. Those who have graduated or completed their upper secondary school (equivalent to a high school education in Japan) and university education in a foreign country geographically, including those expected to complete university education by March 31, 2025.⁵
- II. Those who have graduated or completed their upper secondary school (equivalent to a high school education in Japan) and university education in a language other than Japanese, including those expected to complete university education by March 31, 2025.⁵

Notes

- 1. Japanese universities mentioned in the applicant eligibility criteria (1) ①, ⑥ and (2) ① II, (a) above are universities within the boundaries of Japan as prescribed in Article 83 of the School Education Law.
- 2. The applicant eligibility criteria (1) ②,③ above include the case of having completed a correspondence program provided by a foreign school of said country while residing in Japan.
- 3. Those mentioned in the applicant eligibility criteria (1) ⓐabove refer to any who have graduated from the following schools or educational institutions.
 - The Japan branch of a foreign school designated by the Minster of Education, Culture, Sports, Science and Technology.
 - Post-secondary courses in specialized training college designated by the Minister of Education, Culture,
 Sports, Science and Technology (limited to programs where the program duration is at least 4 years and which satisfy standards determined by the Minister).
 - Universities under the old university ordinances, or higher educational institutions (daigakko) under the acts and government ordinances for establishment of ministries/acts on dependent administrative agencies.
- 4. Those who intend to apply under the applicant eligibility criteria (1) (a) and (2) (1). If must undergo individual screening of entrance qualifications. The applicants will be permitted to apply and to take the entrance examination, only after GSFS approves the applicant as having a valid application after the individual screening of entrance qualifications. Therefore, please contact the Student Affairs Team within the period specified, and submit the designated forms (Please refer to (5) of 11. Notes).
- 5. Those applying for October 2024 admission under Schedule A should read "March 31, 2025" as "September 30, 2024." Those applying for October 2025 admission under Schedule B should read "March 31, 2025" as "September 30, 2025."

3. Selection Methods

- (1) Selection of students for admission shall be conducted based upon a comprehensive evaluation of the results of the applicant's written and oral examination and all other submitted documents.
- (2) Some departments conduct a document screening with the submitted application materials first, and only those who pass the document screening may proceed to taking a written and oral examination. Please be reminded that if an applicant fails the document screening and does not proceed to the written and oral examination, the application screening fee will not be refunded. The detail of selection methods is explained in an entrance examination guide of the department you apply for.

4. Application Method

(1) Please submit your application through the Online Application site. This site can be accessed from the Information on Entrance Examinations page on the GSFS website.

8. Multiple Applications

Applicants are prohibited from doing following:

(1) Applying to two or more departments within GSFS (or Graduate Program in Sustainability Science and any other departments) at the same time.

- (2) Applying for Schedule B when they pass the examination according to Schedule A.
- (3) Applying for Regular Admission and Special Selection for Applicants with Overseas Education in the master's program at the same time.

9. Examination Schedule, Methods, and Venue

- (2) Announcement of the methods of the examinations will be sent to applicants separately. Please confirm the details on the website and in the entrance examination guide of the department to which you are applying.

10. Announcement of Results and Admission Procedures

- (2) Only successful candidates will receive a written notification of passing the examination and forms for admission procedures.
- (3) Telephone, FAX, or E-mail inquiries regarding the results will not be accepted.
- (4) If the proper admission procedures (including the payment of admission fee) are not completed during the designated period, you will be determined to have no intent to enroll, and your application will be processed as a withdrawal.
- (5) Academic Fees and Expenses (planned for the 2025 academic year) that must be paid upon enrollment are as below. Please note that the fees are subject to change. If fees are revised upon the enrollment or while enrolled, the revised fees shall be applied to the next payment required after the revision. MEXT scholars are exempted from paying these fees.

- (7) Applicants not possessing Japanese nationality must have a status of residence that does not hinder their enrollment in graduate schools as stipulated in the Immigration Control and Refugee Recognition Act (1951 Government Ordinance No. 319). This status must be acquired by the time of enrollment.
- (8) As part of the GSFS admission procedure, applicants, except for those applying to the Department of International Studies, who plan to enroll while being employed by a company, government agency, or other organization must submit a letter (format is optional) from their workplace supporting their admission to GSFS.
- (9) GSFS shall use the personal information (name, address, or other information) of the applicants provided during the application process for the following purposes: (i) processing applications and conducting screening in order to select successful applicants; (ii) announcement of successful candidates; and (iii) conducting admission procedures. For enrolled students, their personal information and examination results used for admission selection shall be used for the following purposes: (i) student affairs (school register, etc.); (ii) student services (healthcare, career support, tuition exemption, procedures for scholarships, use of libraries, etc.); and (iii) tuition fee payment.
 - For those who will conduct research at any research institution other than the University of Tokyo after admission, their personal information obtained in the application process may be used for security export control screening at the respective research institution.
- (10) The results of entrance examination tests may be used for the purpose of improving the university's entrance examinations test and/or the education that the university provides.
- (11) Applicants who make any false statements and/or forgery in their application, and/or in any other accompanying forms, statements, or documents, and whose fraud actions in their entrance examination are confirmed with clear evidence may have their admission rescinded even after being accepted or admitted.
- (12) In case of natural disasters or other uncontrollable events, the schedule and method of examination are subject to change. Please check the GSFS website for the latest information.
- (13) Applicants who have been affected by natural disasters such as windstorms and flood may be exempted from paying the application screening fee. The University of Tokyo has established the "The University of Tokyo Security Export Control Regulations" in accordance with Japan's "Foreign Exchange and Foreign Trade Act", and rigorously implements security export control for potential students before and after their enrollment on the basis of these regulations. In particular, pre-enrollment screenings are mandatory for all international students and also for Japanese students in certain circumstances.

Please be aware that applicants who fall under any of the conditions set out in the Act may not receive permission to enroll at the university or may have their research activities restricted after their enrollment even if they have passed the entrance examinations.
